FCP Mission: Empower members to be the nation's food, culinary and nutrition leaders.


Our events and activities have supported FCP's goals:

FCP has experienced steady membership growth since its inception. The 2008-2009 FCP year ended with a record membership of 2,285 and 43 Friends. This is an increase of 142 members from year-end 2007-08. Our members work in diverse settings that include culinary schools, supermarkets, food industry, journalism, public relations, food research, media, education and healthcare.

Financial Status

For 2008-09, FCP concluded the year with a significant positive bottom line.

At year end, FCP's budget reserve status was 44%. This is a major improvement and a result of strong fiscal management and outstanding sponsor support.

Key Activities and Events

- The Executive Committee met via teleconference to conduct Executive Committee transition and initial planning for the year. The Executive Committee met together in June 2008 and again during the Food & Nutrition Conference & Expo (FNCE) in Chicago. During the year, eleven (11) conference calls were conducted.
- The Past Chairs' Council continued to provide support and guidance to the Executive Committee.
- Our sub-group membership continues to grow:
 - Supermarket 320 members
 - > Food Safety 206 members
 - Restaurant/Retail 193
- Educational offerings included 28 continuing professional educational units!
 - Chicago (FNCE) events included a tour of the Mars chocolate plant, two workshops at Washburne Culinary Institute, an exceptional networking event at the Culinary and Hospitality Institute of Chicago, and our business breakfast. The week concluded with a special dinner at Naha Restaurant.
 - > We conducted five (5) book club teleforums
 - We conducted our second webinar.
 - > We conducted ten (10) educational teleforums.
- We initiated work on a recipe contest, which was conducted during this past summer with the Hershey Company.
- We continue to market our Web site's Member Marketplace, showcasing our members' products and services.
