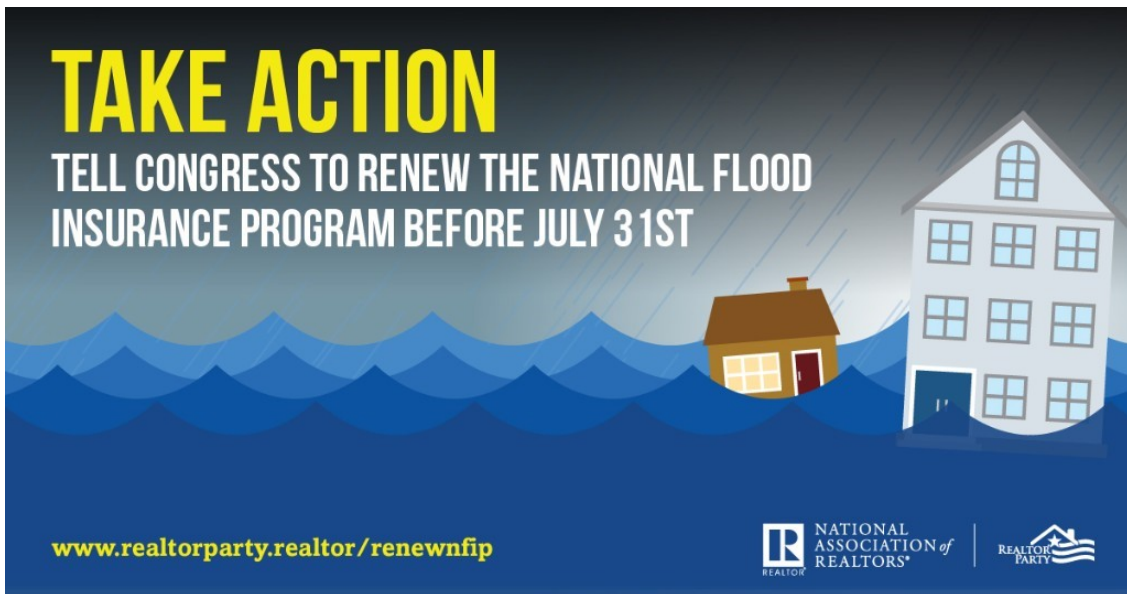

Urge Congress to extend the NFIP and pass meaningful reforms to ensure long-term viability of the program!

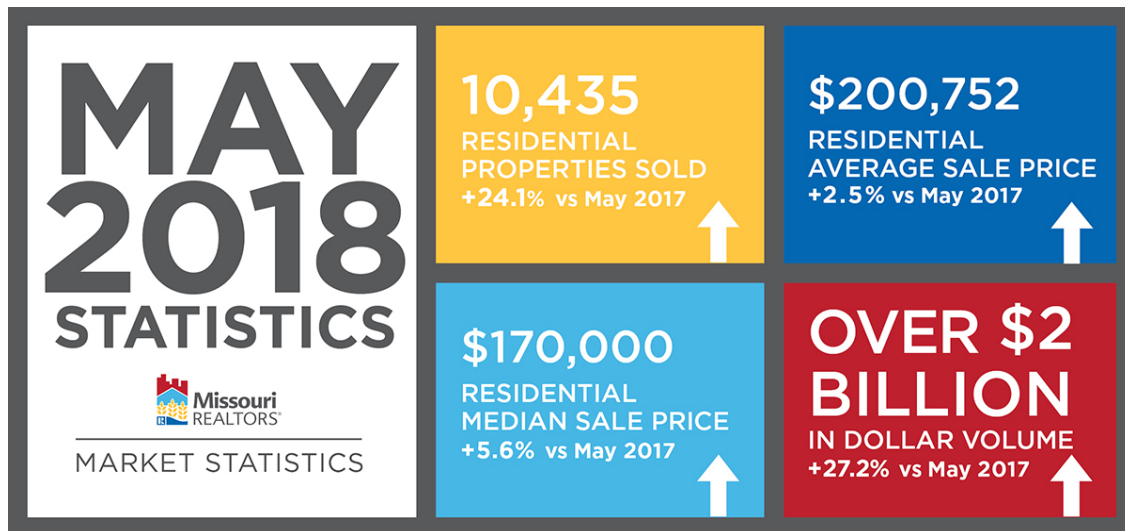
