<b>March 3 - May 15, 2025</b>	<ul style="list-style-type: none"> <li>2026 O2 Committee Application opens on March 3.</li> <li>Members submit one (1) Committee Application.</li> <li>Members should also update their profile on The Landing to ensure bio and profile picture are current.</li> </ul>
<b>April 1, 2025</b>	<b>DEADLINE:</b> To apply for NAR Director election. <i>See membership notices for projected allocation vacancies.</i>
<b>May 1, 2025</b>	NAR Director election for 12/1/2025-11/30/2028 term. <i>Takes place during Spring Business Conference Board of Directors meeting.</i>
<b>May 15, 2025</b>	<b>DEADLINE:</b> O2 Committee Application closes.  <i>NOTE: 2025 Spring Business Conference in Columbia is April 29-May 1, 2025. Application period is open during this conference to maximize opportunity to encourage members to apply.</i>
<b>May 16 - July 31, 2025</b>	Window for: <ul style="list-style-type: none"> <li>Staff to organize and review O2 committee applications.</li> <li>Leadership Team meets to make O2 appointments according to Policy.</li> </ul>
<b>July 31, 2025</b>	2026 State Director allocations determined for each Local Board/Association using membership numbers.
<b>August 1, 2025 (TENTATIVE)</b>	O2 appointment notifications for chairs, vice chairs, and committee members are emailed.
<b>August 5-21, 2025</b>	2026 O2 committees meet virtually to appoint output group leadership.
<b>August 5, 2025 (TENTATIVE)</b>	2026 State Director allocation notices are sent to Local Board/Association AEs.
<b>August 26-30, 2025</b>	All 2026 O2 leadership appointments are finalized.
<b>August 26, 2025</b>	<b>DEADLINE:</b> To apply for Missouri REALTORS® 2027 Treasurer.
<b>September 1, 2025 (TENTATIVE)</b>	2026 O2 leadership appointments are published.
<b>September 25, 2025</b>	Missouri REALTORS® Treasurer election. <i>Takes place during Fall Business Conference Board of Directors meeting.</i>
<b>January 19, 2026</b>	<b>DEADLINE:</b> Local Boards/Association must submit their directors' names along with completed Agreement to Serve to be inducted during Winter Business Conference Board of Directors meeting.
