

The National Association of REALTORS® Code of Ethics cycle ended on Dec. 31, 2021. However, there is a grace period until March 1, 2022. If Missouri REALTORS® is the point of entry for your Local Board/Association and you have not submitted your COE training for cycle 6, please do so as soon as possible so it can be recorded and reflected in your NRDS record immediately.

If your COE training is not received by March 1, 2022, **your NAR membership will be terminated.**
