Roll call was taken from attendance in the room by the Association Executive.

President called meeting to order.

Motion made to approve the October meeting agenda as emailed.

Motion made to approve minutes from the September BOD meeting.

Motions/Recommendations brought forward by committees/AE/BOD/members:

1. Recommendation by the Finance Committee. Motion made to approve the financials for September and the Year-To-Date for 2023. Note: Finance Committee invited BOD to attend their next meeting on November 9th at 10:00 am for the Q&A session with the contractor we are looking at remodeling the conference center kitchen, bathrooms, and ramp.

2. Recommendation by the Finance Committee. Motion made to donate \$1,000 in total to Shop with a Cop in the cities of Joplin, Carl Junction, Carthage, Webb City, Seneca, Neosho, Baxter Springs, and Lamar, at \$125 apiece.

3. Recommendation by the Finance Committee. Motion made to donate \$100 to the Lafayette House for their awareness campaign. This request was brought to BOD directly from the Lafayette House.

4. Recommendation by the Finance Committee. Motion made and amended to reinstate paying the current federal allowable mileage rate instead of the current .27.

After 3rd offense -90-day MLS suspension. After 4th offense - Review done by Board of Directors. * Staff to make sure that MLS rules are provided to every new member, and that current members receive rules and updates. The new rule to go into effect 1/1/24. Notices to go out to membership by staff on 11/1/23 and 12/1/23 by email blast, Facebook post and a note sent directly to the DR's. * Discussion was held, and the staff is to send out the current Bylaws and MLS Rules on January 2, 2024, to the whole membership and do that annually.


