- Established by legislative resolution (SCR3) in 2009
- Collaboration of private and public entities that share a commitment to empowering Utahns to achieve economic stability, opportunity, and upward mobility
- ~50 public and private entities participate
- Chaired by State Treasurer
- Office of State Treasurer oversees and orchestrates the work of the Council

# **Utah Financial Empowerment Coalition 501(c)3**

- Utah Council on Financial and Economic Education was an unfunded mandate
- We formed a nonprofit organization in 2018 to serve as the fiscal agent for financial literacy initiatives
  - The Utah Financial Empowerment Coalition has an independent board of directors
  - A representative of the Treasurer's Office serves as secretary/treasurer of the board
  - The Treasurer's Office performs the administrative work of the organization







### **Utah Women in the Money Conference**





- Over the last five years, the conference has provided Utah women with access to knowledge, community resources, and a support system.
- In 2023, the hybrid conference served nearly 900 women
- Experts representing dozens of nonprofit organizations, government agencies, and community partners serve as speakers and exhibitors

## **Utah Treasurer's Investment Challenge**



- 10-week simulation of Wall Street trading that provides a framework for teaching Utah students about the U.S. economy and financial markets
- Served more than 7,500 students in grades 4-12 last year
- Students can also compete in a statewide writing contest
- Administered by the Utah Office of State Treasurer since 2018. The Utah Financial Empowerment Coalition is the fiscal agent
