

## Volunteer Release and Waiver of Liability Form

This Release and Waiver of Liability (the "Release") executed on(date) by	("Volunteer")
releases Women In Sports and Events, Inc., ("WISE"), a nonprofit corporation organized and existing under t	he laws of the State
of New York and each of its directors, officers, employees, volunteers, representatives and agents (the "WISI	E Affiliates"). In
consideration of being permitted to volunteer for WISE and engage in activities related to serving as a volunte	eer, Volunteer
hereby agrees as follows:	

- 1. <u>Scope of Relationship</u>: I understand that the scope of my relationship with WISE is limited to a volunteer position and that no compensation is expected in return for the services I am providing; that WISE will not provide me with any benefits traditionally associated with employment; and that I am responsible for my own insurance coverage in the event of personal injury or illness as a result of my services to WISE.
- 2. <u>Acknowledgment of Risk</u>: As a volunteer, I understand that the services I provide to WISE may involve risk of physical injury to me or others, or damage to my property, or other consequences, which might result from my own actions, inactions or negligence and/or the actions, inactions or negligence of others, my participation in any WISE event, condition of the premises, weather conditions, or condition of any of the equipment used in any such event. There may also be other risks not known or not reasonably foreseeable.
- 3. <u>Assumption of Risk</u>: I hereby expressly assume any and all risks for injury to person or property, or any other consequence arising out of the volunteer services I provide to WISE and/or my assisting in, participating in, or volunteering in any WISE event, including travel en route to and from such event. I HEREBY WAIVE AND RELEASE MY LEGAL RIGHTS TO SUE FOR ANY INJURY OR OTHER DAMAGE ARISING OUT OF OR RESULTING FROM MY ASSISTING / VOLUNTEERING.
- 4. Waiver and Release: On behalf of myself, my executors, administrators, heirs, next of kin, successors and assigns, and anyone else who might sue on my behalf, I HEREBY WAIVE, RELEASE, and FOREVER DISCHARGE WISE and the WISE Affiliates from any and all claims, causes of action, damages, losses (economic and non-economic), and liabilities of every kind (collectively "Claims"), for death, personal injury, or property damage, which may arise out of, result from, or relate to the volunteer services I provide to WISE, including but not limited to any Claims for theft, damage to any equipment, negligence, partial or permanent disability, Claims relating to the provision of first aid, medical care, medical treatment, or medical decisions (at an event site or elsewhere), and any Claims for medical or hospital expenses.
- 5. Covenant Not To Sue: I FURTHER COVENANT and AGREE NOT TO SUE WISE or any of the WISE Affiliates for any of the Claims that I have waived, released, or discharged herein. I AGREE TO INDEMNIFY and HOLD HARMLESS WISE and the WISE Affiliates from any and all expenses incurred, Claims made, or liabilities assessed against them, including but not limited to attorneys' fees and litigation expenses, arising out of or resulting from, directly or indirectly, in whole or in part, my breach or failure to abide by any part of this Release, and my actions or inactions which cause injury or damage to any other person.
- 6. <u>Insurance</u>: Further I understand that WISE does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health, or disability benefits or insurance. I expressly waive any such claim for compensation or liability on the part of WISE beyond what may be offered freely by WISE in the event of injury or medical expenses incurred by me.
- 7. <u>Photographic Release</u>: I grant and convey to WISE all right, title, and interests in any and all photographs, images, video, or audio recordings of me or my likeness or voice made by WISE in connection with my providing volunteer services to WISE.
- 8. Other: As a volunteer, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of New York and that this Release shall be governed by and interpreted in accordance with the laws of the State of New York. I agree that in the event that any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.
