WHO IS THE WOMEN'S WHITE COLLAR DEFENSE ASSOCIATION?

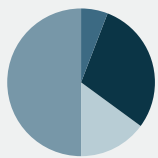

- A vehicle for information sharing related to job openings and other items of interest.

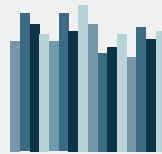
WWCDA GOALS
