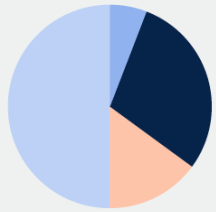

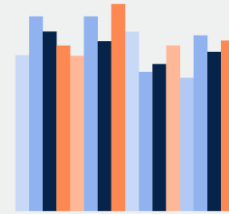

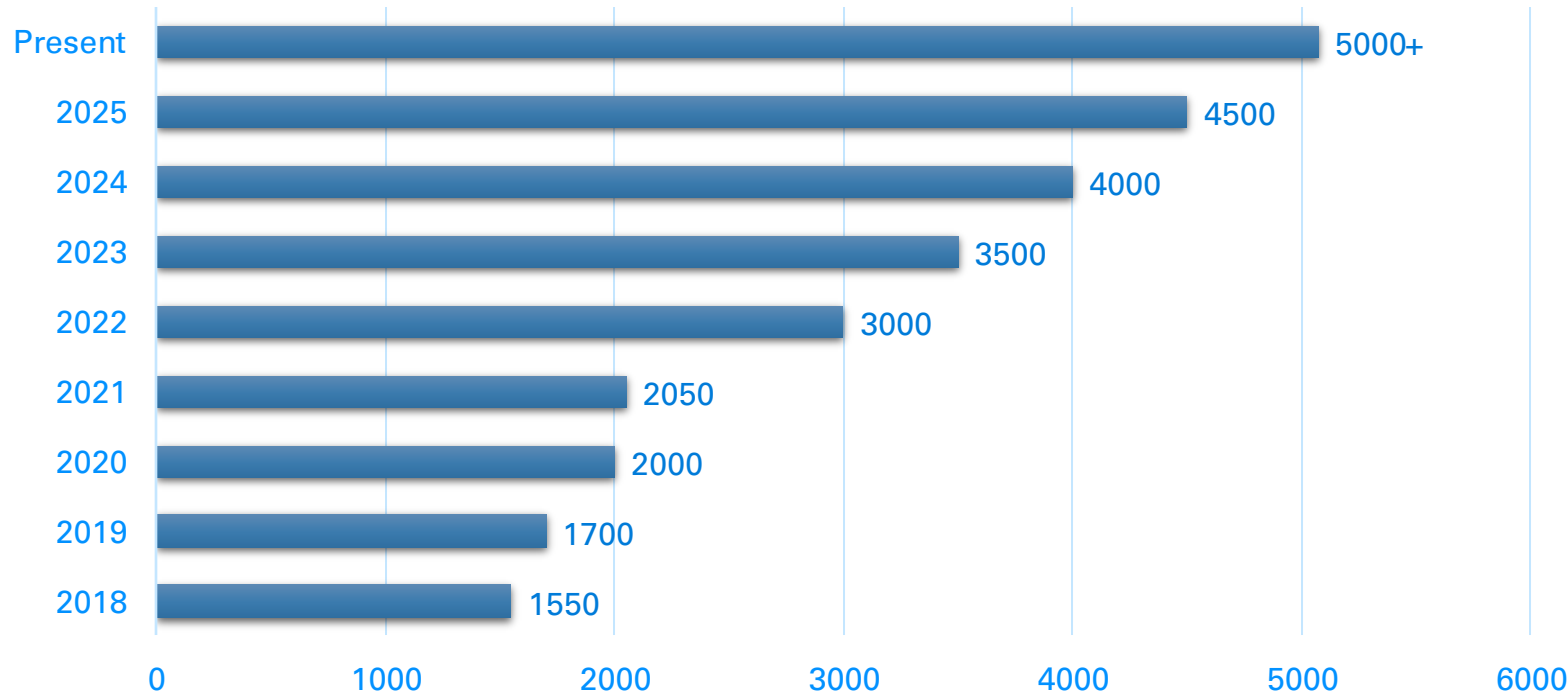

Membership

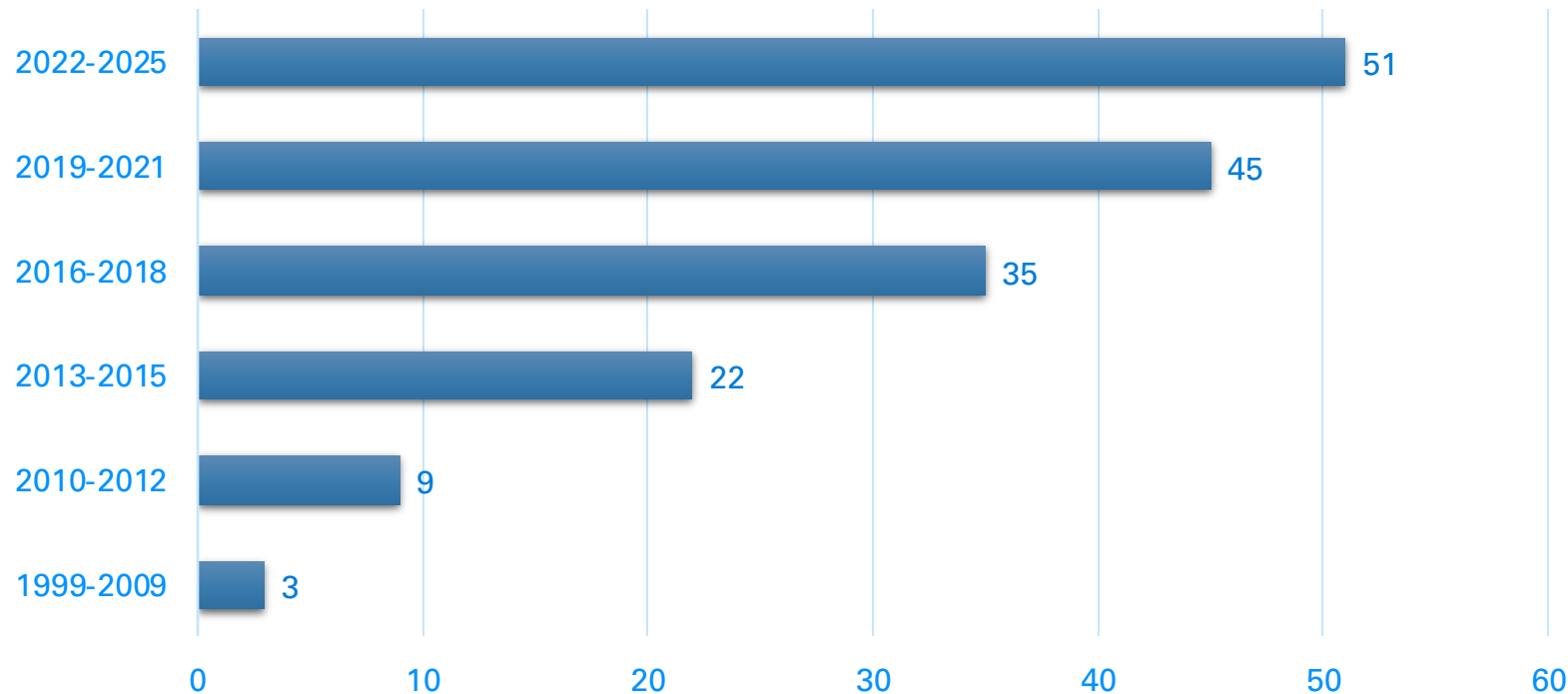

The global presence of WWCDA through its 51 chapters extends to 19 countries around the world.

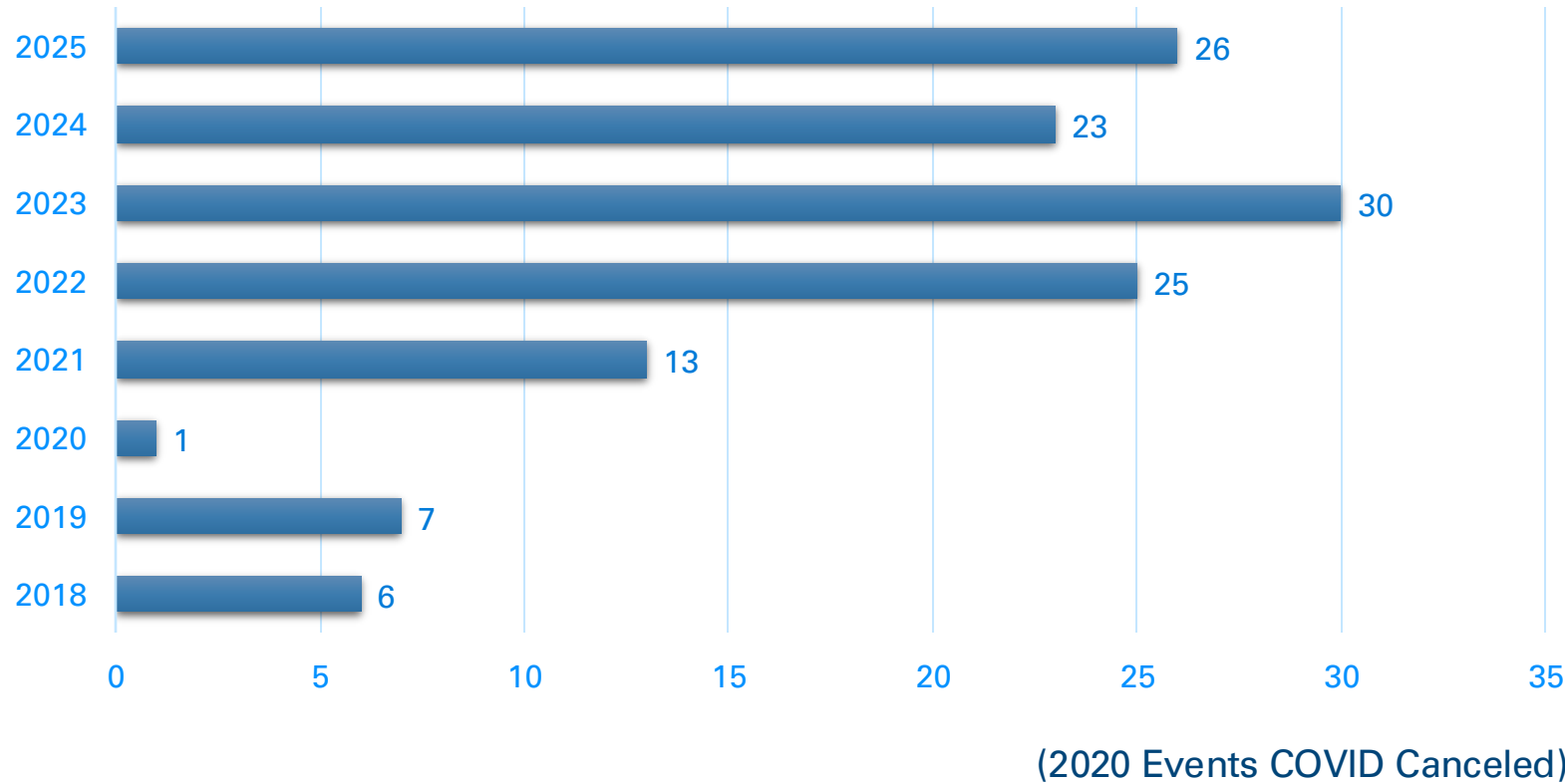
Six Potential New Chapters Are in the Pipeline to be Launched in the Near Future

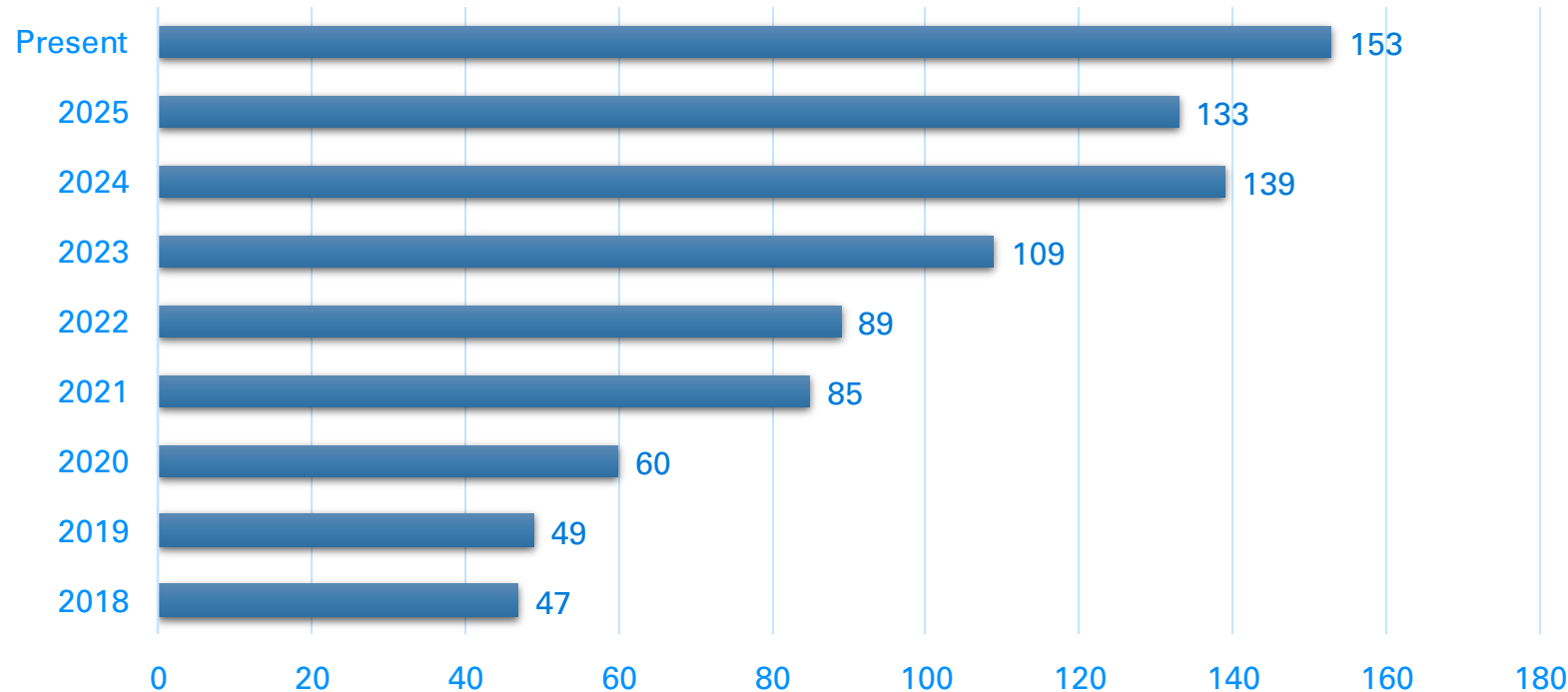


WWCDA partnerships with other organizations continues to be successful. Members have been placed as speakers at these organizations' conferences and received registration discounts to attend.
