Dear United States Senators,

On behalf of YWCA USA, I urge you to VOTE NO on the Tax Cuts and Jobs Act (HR 1/S.1) and any alternative legislation or amendments that similarly threaten the health, economic security. and safety of women, families, communities of color, and the nonprofit sector.

As one of the largest women's organizations in the nation with a nearly 160-year history and daily presence across 47 states and the District of Columbia, we know that any legislative tax proposal must advance the health, economic security, and safety of women, girls, and communities of color, and support a robust non-profit sector that plays such a critical role in meeting community needs. To that end, YWCA will only support legislation that economically benefits working women and lower- and middle-income families; supports a thriving non-profit sector; ensures adequate funding for the programs and services that help women and girls meet their economic, educational, health, and safety needs; and maintains the strength and viability of the health care infrastructure currently provided by the Affordable Care Act (ACA), Medicaid, Medicare, the Children's Health Insurance Program (CHIP), and reproductive health service providers so that women and their families have access to safe, affordable, and comprehensive health care services.

Current proposals under consideration in Congress, fall far short of this mark and threaten the security of women, families, and the non-profit sector by:

- Repealing the ACA's individual mandate, meaning an estimated 13 million people will become uninsured
- Eliminating tax benefits that directly benefit women and families, including tax deductions for childcare and early education, student loan interest, medical expenses, and state and local taxes
- Undermining the strength and vitality of the non-profit sector by eliminating the charitable tax deduction and rolling back the "Johnson Amendment," which preserves the integrity of charitable nonprofits by prohibiting electioneering and partisan political activities
- Increasing taxes on millions of middle-class and struggling families
- Increasing the deficit by \$1.5 trillion over 10 years, thereby undermining the funding for programs and services like Medicaid, Pell grants, and child care, nutrition and housing

Legislators on both sides of the aisle—and more critically, your constituents must have the time needed to fully consider and understand the consequences of legislation that will have a lasting impact for decades to come. Without full hearings and debate, the legislative record lacks the voices and concerns of women and families, and Congress is unable to fulfil its responsibility to fully and openly ascertain the consequences of this legislation.

YWCA USA urges you to VOTE NO on the current Senate legislation, and to return to a bipartisan process that includes full hearings and debate.
